

## **GAME CHANGERS NEWS PRESENTERS APPLICATION PART 1**

### **PARENTAL CONSENT FORM**

#### **To the Parent or Guardian:**

Your child would like to apply to take part in Game Changers for a chance to be a Game Changers News presenter for a day. The show will be transmitted on Sky Sports and On Demand in 2015 and the first half of 2016

For the application to be considered your child needs to provide a completed questionnaire, a signed parental consent form and a video of themselves reading the guide script which can be found on our website [www.skysports.com/gamechangers](http://www.skysports.com/gamechangers).

Videos submitted should be of the applicant reading the script in the manner of a Game Changers News presenter, should be no longer than 2 minutes long and should only feature the applicant. Please note that we cannot accept videos featuring more than one person.

Videos can be submitted via email to [gamechangers@sky.uk](mailto:gamechangers@sky.uk) with the subject title 'Game Changers News'. Videos sent via email should be MP4 or QuickTime files or emailed straight from a smartphone or tablet. Or you can send a DVD via post to the Game Changers address that can be found on the website [www.skysports.com/gamechangers](http://www.skysports.com/gamechangers).

**Fully signed and completed application forms must be attached or enclosed with any videos sent to us.**

Unfortunately we are unable to return any videos.

### **APPLICATIONS**

We cannot accept videos with more than one child in the video. We will be accepting applications for filming during two separate periods each with its own starting and closing date. The parents/guardians of successful applicants will be contacted to arrange a filming date within the corresponding recording period.

**2. 1<sup>st</sup> March 2016 – 30<sup>th</sup> May 2016**

For the application to be considered, your child must be aged between 5 and 12 years old.

The applicants we wish to consider further for the programme will be contacted by a member of the production team. If you have not heard from us within 28 days from the relevant closing date for your child's application then unfortunately it means that your child has not been selected.

Sky Sports Game Changers News is recorded at Sky Studios in Isleworth from 5pm on Monday afternoons. Your child may only appear on the programme if they are able to get here for that time without missing any school. If you live too far away for this to be the case, please fill out the 'special dates' section of the form stating half-term or school holiday dates when your child would be able to appear without missing any school.

Please note that Sky Sports Game Changers **will not** be able to provide any financial assistance with accommodation or travel to and from Sky Studios.

Please complete relevant boxes with a cross [ x ] and add information where required. Please DO NOT alter the rest of the application form. Any applications forms received with standard text missing will be considered void.

All information supplied in this application form will be treated as confidential. It will be stored securely and will be used only in relation to this production and will not be used for any other purpose without your permission.

Involvement in this programme will depend on obtaining the necessary permissions or licence as required and will require a completed contributor's release form.

## **VIDEO FOOTAGE**

You confirm that you hereby give permission for your child to submit their video footage ("Video") to Sky.

You agree and represent that your child has created the Video, or has received permission from, or is authorised by, the owner of any part of the Video to submit it to us and for us to use, reproduce and/or broadcast the Video in connection with the series of programming for Game Changers (the "Series").

By sending us the Video, you agree on behalf of your child that we shall have the right to use, reproduce and/or broadcast (or choose not to use, reproduce and/or broadcast), as we deem fit, the Video provided by you/your child to us, along with your child's name and other details provided in connection with the Series (which may include within the Series itself, on Sky's website(s) and and/or for publicity, marketing and/or promotional purposes for the Series) throughout the universe in perpetuity by any and all means and in any and all media, whether now known or in the future devised, without further payment, liability or acknowledgement to you or your child.

We shall be entitled to (a) edit, copy, add to, take from, adapt or translate the Video and/or use it either as a sequence on its own or preceded, interlaced or followed by such other footage or scenes, as we may feel appropriate for the Series; and that you on behalf of your child irrevocably waive the benefits of and agree not to assert any provision of law known as "moral rights" or any similar laws of any jurisdiction.

You confirm to us on behalf of your child that (a) the Video (whether by way of inflection or gesture or otherwise) will not infringe the copyright or any other right of any person, breach any contract or duty of confidence, constitute a contempt of court, be defamatory or be calculated to bring the Series or Sky into disrepute; (b) the exercise of the rights granted by you and your child to us will not entitle any person to claim any payment from Sky; (c) any opinions voiced in the Video are the person's own and are genuinely and truly held by that person; and (d) you have obtained permission from any person featuring in the Video to be used by us as contemplated under these terms and conditions.

We accept no liability in respect of any Video submitted and used, reproduced and/or broadcast by Sky or by authorised third parties.

## **Privacy Notice**

Sky will obtain, hold and use personal data relating to you as provided on the application form including but not limited to yours and your child's name, address, emergency contact details (e.g. home telephone number), phone/mobile number, medical conditions and special access requirements.

The purposes of such processing are to administer and manage the relationship we have with you and your child. The information you and your child provide will only be used to assess whether your child's application and shall be processed fairly and lawfully and solely for the purpose of determining your child's suitability to be a Games Changers News Presenter. You hereby consent to such data processing by any member of the Sky group, third parties providing Sky with services, the commissioning broadcaster of the programme, our employees, officers, agents and contractors insofar as reasonably necessary for the purposes of the production of the Series. You further consent to transfer of data to a member of the Sky

group or relevant third party that may be situated outside the European Economic Area (E.E.A.) in a country which does not offer a level of data protection compared to the level applied in the E.E.A. In the case of these entities, Sky will put in place adequate safeguards to ensure an adequate level of data protection. In addition, we may disclose your personal information to the extent required to do so by law and/or in connection with our legal rights. Should the application be successful, the information provided may be used by the programme for health & safety purposes and for publicity, marketing and/or promotional purposes for the Series, but will not be used for any other purpose without your permission. Both you and your child's details will be held securely and, except as set out above, will not be passed to any other third parties. All details will only be kept if needed for the duration of the Series and all unsuccessful applications will be destroyed once they have been processed.
